

1. Executive Education



We are pleased to report that a research partnership has been established between Systems Wisdom and Philadelphia University. This is reflected in the migration of part of the Systems Wisdom research website describing the activities of the *Special Task Force for Rethinking Sudden Cardiac Arrest Survival*. This international project was created in 2007 by Larry Starr and Allan Braslow (http://www.systemswisdom.com/allan-braslow) and hosted at the University of Pennsylvania. When Systems Wisdom was formed in 2013, the project moved with the people leading it. It is now supported and hosted by the Philadelphia University graduate studies program in *Disaster Medicine and Management*. Presentations and Workshops

Systems Wisdom has established an education relationship with the *Federal Executive Board (FEB) of Philadelphia.* Established in 1961 by U.S. Presidential Directive, the national network of 28 FEBs are a "forum for communication and collaboration among Federal agencies outside of Washington, DC." The three primary FEB missions include "coordination and support of intergovernmental and community activities; Emergency preparedness, security, and employee safety; and Human capital readiness." The Philadelphia FEB, one of the original, serves a population of approximately 170 federal entities and approximately 45,000 people located in southeastern Pennsylvania, southern New Jersey, and northern Delaware. When it comes to returning favors, workplace attitudes belie vaunted corporate values and fall short of personal ones, research suggests

Peter Belmi and Jeffrey Pfeffer of the Stanford University Graduate School of Business reported that, "In five studies, using both attitudinal and behavioral measures, we consistently found that people primed to think of themselves in an organizational context (e.g., co-worker) felt less motivated to reciprocate and *did* reciprocate less than those in an otherwise parallel personal (e.g., friend or acquaintance) situation." In sum, "*organizational contexts reduce people's obligation to follow the moral imperative of the norm of reciprocity*." (Source: <u>http://bit.ly/1H90g1z</u>)

Structural Capital and Project Processes: Areas for Future Focus

New research points to the systems thinking approach to takle the holistic nature of a project within its environment (Edington, 2005; Pollack, 2007) or a synthetic integrative approach that takes into consideration the quantitative and qualitative features of systems (Pourdehnad, 2007). *Pourdehnad (2007) recommends adding systems models to analytical approaches and educating project managers in an integrative approach towards plan execution.* A systemic viewpoint provides a much richer portrait of the total environment within which a project takes place including a firm's entire portfolio of projects and the collateral associated with the firm's structural capital. Parigi said his and Cook's research on companies operating in the sharing economy is still in progress. "We have some preliminary results that confirm the idea that people's levels of trust toward others can be modified through the experience of participating in this relatively new form of collective action. *If confirmed in subsequent research, and this is a big 'if,' the main implication is that trust can be engineered and that technology can play a crucial role in the process," he said.* (Source: http://news.stanford.edu/news/2015/march/sharing-trust-online-031815.html)
